## Unique to ScriptSwitch Prescribing

#### Making it simple for patients and prescribers

**Quantity Limits** – tackles price and volume, offers prescribers a suggested limit to the quantity of the product being prescribed; helping GPs to navigate the complex world of medicine pack sizes.

"The Quantity Limits feature has been very helpful to flag up to prescribers the correct quantity of semaglutide pens to prescribe, especially for the 0.25mg/dose strength which is an initiation dose only and should be stepped up to 0.5mg/dose after one month, meaning only one 0.25mg/ dose pen needs to be prescribed. We are now exploring other ways to use the quantity limit feature for the benefit of prescribers and the CCG." – Paul Marks, Medicines Optimisation Pharmacist, NHS Devon Clinical Commissioning Group

**Dose Optimisation** – improve adherence, lower pill burden and cost, displaying pop-ups based on drug specific dosages; helping patients to take their medicines and improve outcomes.

**Suppressing switches** – Any drug previously rejected twice is automatically withheld from presenting for a period of 12 months so that prescribing behaviour is reflected within the system; helping lower alert fatigue for busy clinicians.

**Localisation** – customisable profile to include local formulary, priorities and guidelines. An easy-to-use system which allows users to simply add, edit and deploy in real-time, with in-built clinical governance.
